Blue Star Glass, Inc. is a self-certifying organization with appropriate product liability insurance in effect. The presence of our tempered logo is your assurance and our guarantee of conformance to US Safety Glazing Standards. Each facility producing tempered glass performs daily routine tests of production samples to the Code of Federal Regulations Part16, CFR 1201, ANSI Z 97.1 – 2015, the Voluntary Test Methods for Fully Tempered Glass as prescribed by The Glass Association of North America or both. Tempered product of each Blue Star location is routinely audited for compliance by nationally recognized testing agencies under the direction of a licensed engineer. Test reports available upon request. Blue Star tempered glass will also conform to ASTM Standards C 1036, C 1048, & C 1376. This certification is the only guarantee extended. No warranties of breakage by any cause of theory, of merchantability or fitness of the product for any particular purpose is expressed or implied.

No claims for damage of scratches will be accepted after installation.

Purchaser agrees: The use of unmarked (NO LOGO) or non-compliant safety glazing materials in specific hazardous locations as defined by code is unlawful and hazardous. The installer is solely responsible for using the appropriate glazing material and to insure non-safety glazing material is not used in, or resold for use in hazardous or illegal situations. Blue Star Glass only recommends fully tempered glass in areas requiring safety glazing or designs where the inherent risks of tempered glass are understood and acceptable. Fully tempered glass while breaking safety under impact has no structural integrity and will usually fall from the opening in clumps or fractured but unseparated particles. The fallout of debris from breakage may pose threat of injury. Design professionals should consider this inherent characteristic before specifying fully tempered glass. Purchaser also agrees to follow the specific installation, storage and cleaning instructions found in Blue Star Installation Instructions, the GANA Glazing Manual and GANA TD 01-0300 General Guidelines for Cleaning Architectural Glass and TD 02-0402 Heat Treated Glass Surfaces are Different.

No Modification may be made by anyone, except a duly elected officer of Blue Star Glass, Inc. by notary, to the terms of this document verbally or in writing. Blue Star Glass reserves the right to inspect any goods or installations alleging product failure. Blue Star Glass will, at its discretion replace defective product or refund to the purchaser and amount equal to the original purchase price. Replacement product is shipped to the nearest point FOB. Blue Star Glass reserves the right to reject any claims. Claims shall be frilled in writing to the producing branch within ninety (90) days of failure. Address correspondence to the branch listed below. Include installer's name, date of purchase / installation, address of installation and your name, address and phone number.

Waiver of Consequential, Incidental and Other Damages: Purchaser specifically understands and agrees that under no circumstances shall Blue Star Glass be liable for any remedy other than refund or product replacement, INCLUDING WITHOUT LIMITATION CONSEQUENTIAL, INCIDENTAL, ECONOMIC, DIRECT, INDIRECT, GENERAL, SPECIAL OR PUNITIVE DAMAGES ARISING HEREUNDER OUT OF ANY CAUSE WHATSOEVER, INCLUDING WITHOUT LIMITATION INJURY TO PERSONS (INCLUDING DEATH) OR PROPERTY. In the event that any other term herein is found unconscionable or unenforceable for any reason, or any exclusive remedy fails of its essential purpose, this provision of waiver by agreement of consequential, incidental and other damages as set forth herein shall continue in full force.
